**Terms and Conditions**

1. The rented item was handed over in perfect order and conditions. The customer has to return the item in the same condition.
2. The sports equipment (skis, snowboard, snowblade) is handed over in the adjusted state. The customer is liable for damages caused by re-adjusted equipment.
3. The customer has to leave a deposit in form of a personal document or credit card.
4. The handing over has to be confirmed in writing. The rented item is checked by the lessor before handing over and the condition is noted in the handover report. The customer has to complain defects to the rented item. The latter have to be noted in the handover report. The customer is liable for any defects not reported before rent.
5. The customer must take care with the rented item. The use of the rented item follows at own risk. Liability- and accident-insurance shall be made on the customer's responsibility.
6. The customer assures to be at good health and to have appropriate physical conditions to use the rented item. Self-responsibility, prudence and self-assessment are required.
7. Rental items are not handed over to unaccompanied minor persons without permission and signature of the legal representative. The legal representative has to inform the lessor about the physical conditions of the minor customer

and assures good health and appropriate physical conditions. The legal representative is fully responsible for the minor customer.

8. Sublease of the rented item is forbidden.
9. The return of the rented item is confirmed in writing. The returned rental item is checked by the lessor and the condition is noted in a return report. Defects or damages of the rented items have to be communicated to the lessor before return.
10. The customer is held liable for the caused damage of the rented item up to 70% of the selling price.
11. The mounting of stickers or other objects (such as GoPro cameras) of any kind is forbidden. The customer is completely held liable for the caused damage of the rented item up to 70% of the selling price.
12. The customer is held liable for lost or stolen rental items. In this case, the lessor can claim an amount up to 70% of the selling price. In case of theft, the customer has to file a complaint to the local police within 24 hours and report the theft immediately to the lessor. **Ski poles are not covered by insurance!** Lost, damaged (broken or bend) or stolen ski poles are charged to the lessor (Aluminum CHF 15.- / pole and Carbon CHF 25.- / pole).
13. Is the rental item excessively dirty, a contribution to expense of up to CHF 20.- can be raised.
14. No claim of reimbursement can be claimed if the customer is compelled to return the rented item before the end of the set time (in case of accident or disease).
15. The next rental period will be claimed if the rental item is returned after expiry of the set rental time.
16. Seasonal renting equipment has to be returned until the 15.05.2026 (end of seasonal renting is 30.04.2026). For any equipment returned later, a

contribution to expenses of CHF 25.- is settled. Rented items are not taken back after the 01.06.2026 and the lessor can claim an amount up to 70% of the selling price. The invoiced amount has to be paid 10 days after receipt of invoice.

17. The present terms and conditions and subsidiary the Swiss code of obligations are applied.
18. Void terms do not influence the remaining terms and conditions.
19. When renting ice skates, it is expressly pointed out that Schwarzsee is a frozen lake (natural ice). Holes / crevices and falling ice must be expected. Even if the lake is approved by tourism and the community, Side Cut Sports declines any liability. Please never let children step onto the ice unsupervised.
